Water Detector and Alarm

Operational Overview

The WaterWatcher is designed to sense water leaks. When it does it will sound an alarm and de-energize its output, turning off the appliance causing the leak. The LED indicator on the front of the control module is green when the output is energized and red when it is de-energized. Once the WaterWatcher is triggered, it will stay triggered until reset, which is done by unplugging it from the wall outlet.

Installation

1. Plug the Control Module into a 120 VAC outlet

2. Plug the appliance into the

3. Place sensor in optimal location to detect potential sources of leaks. Sensor should be placed with probes facing down and label side up.
